Communications Approval

Communications List; Sup. Floyd moved seconded by Sup Schatz to approve the Communications List, Motion carried.

Citizens' Concerns; Beverly Johnson reported that Representative Nolan's office had contacted her and would like to use the town hall June 21, 2016 from 11:45-12:45 to answer any questions that citizens might have. Jordan Metza, a member of his staff will be the one representing him.

Reports;

Building and Grounds; Sup Anderson reported the front Garage doors of the Fire Hall have been repaired and serviced The stairs in the Fire Hall are completed and we are waiting for the electrical. Also, the Snow and Ice warning banners are completed and will be placed later.

Roads; Sup Floyd reported that the roads will be regraded probably on Thursday. Then on Friday the Surface Stabilization will be applied.

Website; Sup Urban reported the Fire Wise information has been put on the website.

Treasurers Report:
