Old Business; Mesabi Bike Trail – Bob Manzoline-explained the difference in the Trail Alignment. It will be adjusted and necessary landscaping will be done. Building and Grounds; Sup Anderson reported The construction for the storage above the Fire Chief's office would be starting as soon as it warms up, Construction cost would be \$1,130.00, the lighting would be done in LED and cost would be about \$1,000.00. The Snow and Ice Banners for the front of the Town Hall are being prepared for next year's winter season...Sup Anderson reported he discussed in detail to the Mesabi Bike Trail representatives about realignment changes. They agreed that they would be responsible for all needed landscaping.
